# Addendum to Professor Eytan Sheshinski's

## Curriculum-Vitae

### Experience in Corporate Restructuring:

Professor Sheshinski was Chairman of the Board of Directors of Koor Industries, Israel's largest industrial conglomerate (\$3.2 billion annual sales) from 1990 to 1995. At the time he became chairman the company was in bankruptcy procedures, having stopped (in 1989) payments on its \$1.4 billion debt. The company was wholly owned by Israel's Trade-Union (`Histadrut'), with more than one hundred subsidiaries operating in diverse areas such as telecommunication, electronics (military and civilian), chemicals (pesticides and secticides), construction inputs (steel, cement, ceramics, etc.) food and more. The company was centrally managed and served as a clearinghouse, with profitable companies subsidizing loosing ones (`cross-subsidization') and an inflated work force, in excess of 35,000 employees.

The new Board of Directors, headed by Professor Sheshinski and a new management team, negotiated a Comprehensive Financial Agreement with a consortium of the creditor banks

(concluded in September 1991), which swapped stock options for debt. The turnaround plan adopted by the new management changed Koor's structure and performance dramatically. Koor became a decentralized holding company, with thirty-five autonomous core-subsidiaries. Losing companies have been sold or closed and the number of employees was reduced to 17,000. All cross-subsidization was eliminated. Professor Sheshinski was intensively involved in the restructuring of Koor, in particular in the design of a model that was used to optimally parcel the debt of the holding (Koor Industries) among its subsidiaries, a pre-condition for the selling of shares to the public. To repay the debt, Koor raised capital on the Israeli and the U.S. stock markets by means of public offerings of shares amounting to \$500 million in 1993 (a quarter of all the capital raised that year in the Israeli stock market). Today, most of Koor's subsidiaries are publicly traded. Koor's shares are currently traded at a company value of \$1.2 billion. Incentive plans for management and workers were successfully implemented. Less than two years later, Koor became the most profitable Israeli industrial corporation (net profits were \$160 million in 1993 and \$140 million in 1994). The Comprehensive Financial Agreement, which stipulated a twelveyear period of banks' control of the company, was terminated in 1992, less than two years after its initial adoption! This dramatic turnaround became a case study at Harvard's Business School.

In June 1995, Shamrock Holdings of the U.S. bought a controlling interest in Koor industries and its president replaced Professor Sheshinski as Chairman of the Board of Directors. His main mission completed, Professor Sheshinski remains, however, a strategic advisor to Koor Industries and is on the board of its two major subsidiaries (Tadiran — electronics and telecommunications and Makhteshimn — chemicals and pharmaceuticals).

Professor Sheshinski, an expert on Public Economics and Privatization, was appointed by the Israeli government as a member of a committee whose task was to recommend methods to accelerate the sale of state-owned enterprises, including the free distribution of stock options of these enterprises to the public (`mass-privatization', different but with some similarities to the East European experience).

## Consulting at Harvard Institute of International Economic Development (HIID)

In 1996, Professor Sheshinski was appointed Director of the International Program on Privatization and Regulatory Reform at the Harvard Institute of International Development of Harvard University. The program engages in educational, consulting and research activities in the area of Privatization, i.e., the sale of State Owned Enterprises (SOES). In the case of infrastructure monopolies, privatization entails the establishment of regulatory schemes. Regulatory regimes differ across countries and are the subject of much research and policy.

Professor Sheshinski organizes an annual one-month workshop on Privatization at Harvard University (Cambridge, Mass.) in July, aimed at top policy makers, managers of SOEs and economists from around the world. Similar workshops have been conducted in Kuala Lumpur (Malaysia) and Cairo (Egypt). The program has consulting agreements with USAID (jointly with KPMG-Pete, Marwick) and with *Pro-Democratia*, a European consulting group (headed by Georges de Menil), which operates in CEE (East-European) countries on restructuring and privatization. Work has focused on Romania and is currently engaged in targeting privatization proceeds and capitalization for the initial funding of a mandatory Pension System.
